✿ The System of Administration of Health and Safety on the Job: what is it?

The norm **OHSAS 18001** (Occupational Health and Safety Assessment Series) defines a system of administration of Health and Safety on the job, not the security of the products/services. The **OHSAS 18001** defines a "modus operandi", shared and established in the activity of the organization, which goes beyond the formal aspects of the implementations of the Law (626). **The OHSAS 18001** is the only norm in the sector that can be "certified". The structure of the **OHSAS 18001** traces, with diverse finality, like that of all the other better-known norms like the ISO 900.

✿ The System of Administration of Health and Safety on the Job: why conform to the OHSAS 18001?

The **OHSAS 18001** in comparison to the laws in place: ● emphasizes the research of health and safety on the job ● extends participation of the system to all the organization, going beyond the simple definitions of legal responsibility ● encourages valuations of efficiency and global efficiency, on all the implied processes, not limited to the final performance and at a level of reliability of conventional presidents.

The System for the continuous improvement of performance develops on two tracks: The Establishment (Politics, Planning, Function), and Maintenance (control and corrective action, reexamination). The monitoring system of the performances is similar to that of other administrative systems (quality, environment), administering objectives of Health and Safety equal to economic and/or qualitative objectives. Moreover the formation and the training of all subjects in the structure is the fundamental element for the Organization to participate in its development.
